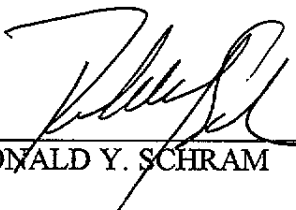

The manner in which directors are to be elected shall be as stated in the bylaws.

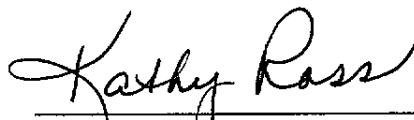
ARTICLE FIVE -

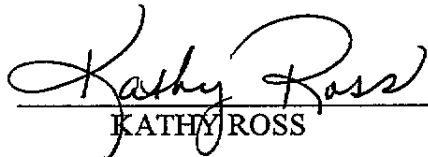
