OF

INCORPORATION

ARTICLE ONE: NAME

The name of the Corporation shall be:

THE JOY OF LIVING CHURCH OF GOD, INC

ARTICLE TWO: THE PURPOSE OF THE CORPORATION

The general purpose for which the Corporation is being incorporated is stated in Article XIII.

ARTICLE THREE: NON-STOCK

This is a non-profit corporation and therefore will not have stock.

ARTICLE FOUR: PRINCIPAL OFFICE AND REGISTERED AGENT

The principal office of the Corporation is located at 455 North Haverhill Road West Palm Beach, Florida 33415, County of Palm Beach and the name of the Registered Agent is Eustace Douglas at 3909 Heath Circle North in the City of West Palm Beach, Florida.

ARTICLE FIVE: BOARD OF DIRECTORS

The number of Directors constituting the initial Board of Directors is four. Directors are elected or appointed by the church in general business section with the voting members of the Organization, and by a two third majority vote.

Each members of the Board of Directors is electer or appointed for a four term and may be elected or appointed by the voting members to serve other terms as stated in the bylaws.

The quorum for the transactions of business by the Board of Directors shall be One director, one of which have been appointed by the organization. The act of the quorum of Directors shall be the act of the Board of Directors.

ARTICLE TWELVE : SHAREHOLDER AGREEMENT

There will be no shareholders agreement, since the Joy Of Living Church Of God Corporation is a non- profit Tax exempt Corporation and will not be issuing shares, But will be totally owned and operatet by the organization.

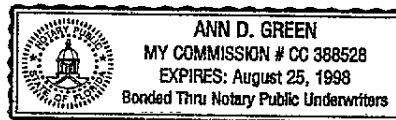

### ARTICLE THIRTEEN

Said Corporation is organized exclusively for charitable , educational, religious or scientific purposes, within the meaning of section 501 ( c ) ( 3 ) of the Internal revenue code (Or corresponding section of any future Federal tax code.)

### ARTICLE FOURTEEN

No part of the net earning of the Corporation shall insure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay resonable compensation for the services rendered and to make payment and distribution in furtherance of section 501 ( c ) ( 3 ) purpose. No substantial part of the activities of the Corporation shall be the carrying of propaganda, or other wise attempting to influnce legislation, and the corporation shall not participate in, or intervene in (including the publishing or disttribution of statements ) any political campaign on behalf of or in opposition to any canditate for public office.

Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activites ont permitted to be carried on ( a ) by a corporaton exempt from Federal income tax under section 501 ( c ) ( 3 ) of the Internal Revenue Code ( or corosponding section of any furture Federal tax code ) or ( b ) by a corporation, contributions to which are deductible under Section 170 ( c ) ( 2 ) of the Internal Revenue Code ( or corresponding section of any furture Federal tax code )

### ARTICLE FIFTEEN

Upon dissolution of this Corporation assets shall be distributed of one or more exempt purposes within the meaning of Section 501 ( c ) ( 3 ) Of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or correesponding section of any furture Federal tax code, or shall be distributed to the Federal government, or to a State or local government for a public purpose.




