ARTICLES OF INCORPORATION
OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: UNITED HAITIAN ATHLETIC FOUNDATION, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 9965 MIRAMAR PARKWAY, SUITE 124, MIRAMAR, FLORIDA 33025

ARTICLE III - PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

Sponsor Haitian tennis athletes - providing equipment, racquets, clothing and footwear, enabling players to attend tennis camps and pro centers, sponsoring players into tournaments, providing tutors when appropriate, assisting high school students prepare for college, fostering confidence and a "can do" attitude.
