Dear Division of Corporations;


I am writing to you in order to get Pamarvele Youth Soccer Seeds, Inc. reinstated by the State of Florida. The paperwork to incorporate this non-profit organization was originally filed on May 19, 1998 and the document number assigned was N98000002844. However, even though we sent you a check for \$61.25 back in 1999 for the year 1999 (and the check was cashed by your office), on September 24, 1999 your office filed the "Administrative Dissolution for Annual Report" (I am not sure this is the correct name for the report). When I called the reinstatement office yesterday, I was informed that this was because you had sent us a "Notice to Correct" form in response to our check back in 1999, which we were to fill out and return to you. However, we never received that form. I was told that informing you of this fact would allow you to waive the \$175.00 late filing fee. Additionally, I am now a director with the organization and assisting the current president (who is also the original president). He did not understand that the non-profit organization must pay \$61.25 each year in order to stay registered, so after the organization was dissolved by you back in 1999 and he received no information in the mail, he assumed everything was just fine.

Upon speaking with your office yesterday, I learned that I could send you a check in the amount of \$192.50 to get Pamarvele Youth Soccer Seeds, Inc. reinstated by the State of Florida. This check would include \$61.25 for the years 2000, 2001 and 2002. Please apply the check that we sent you for 1999 to the year 1999. The \$8.75 balance, I was told, would get me new originals of the two documents I received when we registered the organization back in 1998. The originals that we received back then are either destroyed or lost. I am talking about (first) the letter with the State of Florida / Department of State header at the top and the state seal of Florida and Katherine Harris' signature at the bottom that states "I certify from the records of this office that PAMARVELE YOUTH SOCCER SEEDS, INC. is a non-profit corporation organized under the laws of the State of Florida, filed on May 19, 1998. The document number of this corporation is N98000002844." Second, we need an original for the letter with the Florida Department of State header and the Division of Corporations footer from your New Filing Section basically saying the same thing as the previous letter I described above and a little more.

With the check, I am also enclosing your reinstatement form, which I downloaded off the net.
