# ARTICLES OF INCORPORATION

OF

# HOLY GHOST & FIRE CENTER, INC.

We, the undersigned, acting as incorporators of a NOT FOR PROFIT corporation under Chapter 617 of the Florida Statutes, hereby associate ourselves together for the purpose\_of incorporating and effecting such corporation and do adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of the corporation shall be: HOLY GHOST & FIRE CENTER, INC.

## ARTICLE II - PRINCIPAL PLACE OF BUSINESS & MAILING ADDRESS

The principal place of business is 1305 Delaware Avenue, Ft. Pierce, FL 34950; and the mailing address of this not-for-profit corporation shall be: 2110 N. 45th St., Fort Pierce, FL 34946.

# ARTICLE III - PURPOSE(S)

The general nature and object of this corporation shall be the edification and promotion of faith in God's word, the salvation of souls, the proclamation of the saving Grace of God, the introduction to the One True and Living God, Jesus Christ, and to proclaim the power of the Holy Ghost; to promote wholesome standards of godly living and worship; to defend the true faith of One True God until He comes; to buy, manage, own and hold and sell real estate and personal property necessary and proper for the place of public worship and to carry on educational and charitable work under the rules and order of the Constitution as adopted by the congregation of the said church and corporation.

#### ARTICLE IV - BOARD OF DIRECTORS

The method of election of directors is stated in the Bylaws of the corporation.

#### ARTICLE V - LIMITATION OF CORPORATE POWERS
