We, the undersigned, hereby come together for the purpose of becoming incorporated under the laws of the State of Florida applicable to incorporation Not For Profit Corporation Act, and the following proposed Charter.

Article I

Name

The name of the Corporation shall be "UNIAO CULTURAL BRASILEIRA, INC. " located in Broward County, Florida.

Article II

Address
