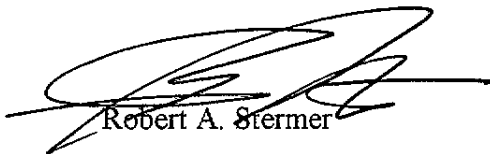

ARTICLE I

Name. The name of this corporation shall be Restorative Justice Ministry Network of Florida, Inc.

ARTICLE II

Address of Principal Office. The principal office of the corporation shall be 222 SW Broadway, Ocala, Florida 34474.

ARTICLE III

Purposes. This Corporation is organized exclusively for educational and charitable purposes, within the meaning of Section 501(c)(3) of The Internal Revenue Code of 1986 (or corresponding section of any future tax code).
