### ARTICLES OF INCORPORATION OF

IGLESIA DE CRISTO

"SU PODER EN ACCION" CORP.

("HIS POWER IN ACTION" CHURCH OF CHRIST CORP.)

The following are the Articles of Incorporation of "Iglesia de Cristo Su Poder en Accion" Corp., a non-profit corporation.

#### ARTICLE I

The name of the corporation shall be:

IGLESIA DE CRISTO "SU PODER EN ACCION" CORP.

#### ARTICLE II

- 1. One of the objectives and purposes of this corporation is to establish and maintain a church or churches and or a Christian ministry and provide a place of worship in Florida and in other states of the nation.
- 2. The general nature of the business or businesses to be transacted by the corporation will be the carrying of the business, businesses, and all related activities, duties, acts and procedures connected with providing for the needy, the preaching and dissemination of the gospel of Jesus Christ and the Word of God, to the end that the people of God may be conformed to the image of Jesus Christ through television, radio, newspaper and any other forms of mass communication, and through the establishment and management of Gospel missions, churches and other ministries, to be

and to grant aid an pay reasonable compensation for services actually rendered to persons, firms and corporations for such purposes, to establish a bookstore or bookstores.

- J. To establish a program to visit the prisons, with the main purpose of developing a prevention program inside the system, and to make the inmates aware of the Aids epidemic, providing Bible classes, counseling and psychotherapy that could provide the enotional and spiritual support needed to help inmates cope with the system and prepare them to be model citizens when released.
- K. To help the community in providing services that will include aid to the homeless male and female, providing shelter, food, clothes, counseling that could help them integrate back into society, support groups, Bible classes and referrals to community/governmental medical agencies.
- L. To help the community in general conducting seminars and conferences in Public Schools and churches for Aids prevention, and drug and alcohol prevention.
- M. To help the community in providing aid to female and male HIV patients giving them shelter, food, clothes, counseling, support groups, Bible classes, referrals to community/government medical agencies and recuperation program for substance abusers. To provide comprehensive care services for children, youth, women, and families who are infected or affected by human immune deficiency HIV and to link comprehensive care.
- N. Establish a program to visit the hospitals and the elderly, providing the spiritual and psychosocial support needed to help the sick.

### ARTICLE III ENABLING POWERS

In order to provide any and all of the services set out above, the corporation shall have the power:

a) To apply for and obtain any and all such licenses and permits of whatever location needed as shall be deemed necessary for the lawful functions of the corporation.

b) To buy, sell or otherwise acquire, handle, hold and dispose of real and personal property or any interest therein; to enter into transactions of any kind or character whatsoever with respect to such real or personal and to dispose of it as may be required.

- c) To manage, supervise, operate, control, lease, let and sublet offices, office buildings, and all other kinds and character of property of every nature whatsoever.
  - d) To purchase, or otherwise acquire, and to own and mortgage, pledge, sell, assign and transfer or otherwise dispose of, and to invent, trade, deal in and deal with goods, wares, merchandise and other personal property of every class and description whatsoever.
  - e) To buy, sell, manufacture, repair, alter and exchange, let or hire, export and deal in all kinds of articles and things which may be required for the purpose of any of the said businesses, or commonly supplied or dealt in by persons engaged in any such businesses, or which may seen capable of being profitably dealt with in connection with any of the said businesses.
  - f) To guarantee, acquire by purchase, subscription or otherwise, hold for investment or otherwise, sell, assign, transfer, mortgage, pledge, or otherwise dispose of the shares of the capital stock of, or any bonds, securities or evidences of indebtedness created by any other corporation or corporations of the State of Florida, or any other state or government, domestic or foreign; and while the owner of any such stocks, bonds, securities or evidences of indebtedness, to exercise all the rights, powers and privileges of ownership, including the right to vote thereon for any and all purposes; to aid by loan, subsidy guaranty, or in any other manner whatsoever so far as the same be permitted in the case of corporations organized under the General Corporation Laws of the State of Florida, any corporation whose stocks, bonds, securities or other obligations are or may be in any manner and at any time owned, held or guaranteed, and to do any and all other acts or things for the preservation, protection, improvement, or enhancement in value of any such stocks, bonds, securities or other obligations; and to do all and any such acts or things designed to accomplish any such purpose.
    - q) To acquire, hold, own, dispose of, and generally deal in grants, concessions, franchises and contracts of every kind; to cause to be formed, to promote and aid in any way in the formation of any corporation, domestic or foreign.
    - h) To act as financial, business and purchasing agent for domestic and foreign

corporations, individuals, partnerships, associations, state governments or other bodies.

- i) To acquire in any manner, enjoy, utilize, hold, sell, assign, lease, mortgage or otherwise dispose of, letters patent of the United States or of any foreign country, patents, patent rights, licenses and privileges, inventions, improvements and processes, copyrights, trademarks and trade names or pending applications therefor, relating to or useful in connection with any business of the corporation or any other corporation in which the corporation may have an interest as a stockholder or otherwise.
- j) To borrow money and contract debts when necessary for the transaction or business or for the exercise of its corporate rights, privileges or franchises, or for any other lawful purpose of its incorporation; to issue bonds, promissory notes, bills of exchange, debentures and other obligations and evidences of indebtedness payable at a specified event or events, secured or unsecured, the right to convert the principal thereof into any preferred or common stock of the corporation, how or hereafter authorize, upon such terms and conditions as shall be fixed by the Board of Directors may deem judicious, subject, however, to the provisions of Article III hereof.
- k) To acquire by purchase, subscriptions or otherwise, and to hold for investment, and to own, hold, sell, vote and handle shares of stock in other corporations.
- 1) To have one or more offices, conduct its business and promote its objects within and without the State of Florida, in other states, the District of Columbia, the territories, possessions and dependencies of the United States, and in foreign countries, without restrictions as to place or amount.

In GENERAL, to do any or all of the things herein set forth to the same extent as natural persons might or could do and in any part of the world as principal agents, contractors, trustees, or otherwise, within or without the State of Florida, either alone or in company with others, and to carry on any other business in connection therewith, whether specifically stated herein or otherwise, and to do all things not forbidden, and with all the powers conferred upon nonprofit corporations by the laws of the State of Florida.

It is the intention that each of the objects, purposes, and powers specified in each of the paragraphs of this third Article

of these Articles of Incorporation shall, except where otherwise specified, be nowise limited or restricted by reference to or inference from the terms of any other paragraph or of any other articles or paragraphs of these Articles of Incorporation and shall be regarded as independent objects, purposes and powers, and the enumeration of specific purposes and powers shall not be constructed to restrict in any manner the general terms and powers of this corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature. The enumeration of objects or purposes herein shall not be deemed to exclude or in any way limit by inference any powers, objects, or purposes which this corporation is empowered to exercise, whether expressly by force of the laws of the State of Florida, now or hereafter in effect, or impliedly by any reasonable construction of said law. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

#### ARTICLE IV CAPITAL STOCK

This corporation is authorized to operate without stock as per the Laws of Florida.

#### ARTICLE V BEGINNING CAPITAL

The amount of capital with which this corporation will be started has not been determined yet.

#### ARTICLE VI TERM

The existence of the corporation is to be perpetual.

#### ARTICLE VII PLACE OF BUSINESS
