
Dear sirs/Madam:

The above mentioned Religious Organization submitted it's first annual report for the year 1999., with the correct fee of \$61.25 attached, However, unbeknown to us, your office returned the report because it did not specify the officers for the organization and the U.S. Post office failed to deliver your reply to our address. Our church is located in a small shopping center for which we obtained a zoning variance, the only thing which has never happened correctly has been the delivery of mail to our correct address. If you check your records we encountered the same problem when we incorporated and the Certificate of Incorporation was returned to you because even then the Post Office failed to deliver the mail. The post office has apologized over the years for this problem citing that we are located in an overlapping zip code, but it has not corrected the situation. For this reason we formally notified the Florida Department of State in May 28, 1998, to mail any communication to Angel Nunez, Secretary and Registered agent for the church.

We only found out about this matter because we called several times to find out why we never received the Annual Report for 2000. Can you please help to reinstate our church. We have attached a Reinstatement form as well as a check for \$61.25 to cover this years filing fee. We most respectfully request that you waive any late fees since we never received the annual report forms for this year and the error in delivery was made by the Post Office.
