- I. The name of the corporation is All God's Children Ministries, Inc.
- II. Its registered office in the State of Florida is located at 1154 Galahad Drive, Casselberry, FL 32707, County of Seminole. The registered agent in charge thereof is Orville Baldrige.
- II. The address of the principal office of the corporation and mailing address is 1154 Galahad Drive, Casselberry, FL 32707.
