The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The specific purpose(s) for which the corporation is organized is(are): THE PURPOSE OF THIS CORPORATION IS TO PROVIDE AN ENTITY PURSUANT TO FLORIDA STATUTE CHAPTER 723 FLORIDA MOBILE HOME ACT PROVIDING FOR AN INCORPORATED ASSOC. TO REPRESENT HOMEOWNERS AND TENANTS IN THE PARK KNOWN AS HOLIDAY MOBILE PARK HOMEOWNERS ASSOC. LOCATED IN THE COUNTY OF MARTIN, STATE OF FLORIDA IN THE UNITED STATES

ARTICLE IV MANNER OF ELECTION OF DIRECTORS OF AMERICA

The manner in which the directors are elected or appointed is: OFFICERS AND DIRECTORS SHALL BE ELECTED AT THE ANNUAL MEETING HOLD IN THE MONTH OF MARCH OF EVERY YEAR. THE TERM OF OFFICE SHALL BE FOR ONE (1) YEAR WITH OFFICERS AND DIRECTORS LIMITED TO TWO (2) CONSECUTIVE TERMS OF OFFICE. TERM OF OFFICE MAY EXCEED TWO (2) TERMS IN EMERGENCY SITUATIONS BY APPROVAL OF (2/3) TWO THIRDS MAJORITY OF VOTES OF THE MEMBERSHIP ATTENDING.
