The manner in which the directors are elected is by nomination and voting by management committee members in accordance with the bylaws of the corporation.

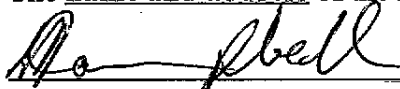

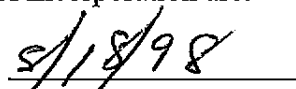
