ARTICLES OF INCORPORATION

OF

We, the undersigned, with other persons being desirous of forming a nonprofit corporation, under the provisions of Chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I

The name of the corporation shall be:

BLOODHOUND FOOTBALL BOOSTERS, INC.

The address of the principal office of this corporation shall be Post Office Box 284, Auburndale, Florida 33823, and the mailing address of the corporation shall be Post Office Box 284, Auburn-dale, Florida 33823.

ARTICLE II

The general purpose of the business of businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida is to support the Auburndale High School football program and football players.

ARTICLE III

The manner in which the directors are to be elected or appointed is as stated in the bylaws.

ARTICLE IV

The initial registered office in the State of Florida is to be located at 121 Auburn Road, Auburndale, Florida 33823. The name of the initial registered agent of the corporation at that address is Don Parrish.

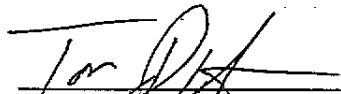
ARTICLE IX

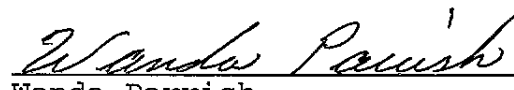
