## ARTICLES OF INCORPORATION

*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

### ARTICLE I NAME

The name of the corporation shall be: Mount Ararat Missionary Baptist Church of Orange Park, Inc.

### ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are): The corporation is organized exclusively for religious, charitable, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, rescue missions, day-care centers, camps, and single-parent/senior citizen homes.

The church shall also ordain and license men to the Gospel ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; educate believers in a manner consistent with the requirements of the inerrant, infallible Word of God, The Holy Bible, both in Sunday Church School and weekday schools of Christian education; maintain ministry activities in the United States and any foreign country.

The purpose of this local Church shall be to: 1) Seek the salvation of the lost, through the preaching of the Gospel of Jesus Christ 2) Adhere to the preaching of the Gospel for the reproof, rebuke and exhortation of the saints 3) Teach the doctrine of the scriptures 4) Promote and encourage faith-filled prayer 5) Dignify and support the Gospel ministry 6) Aid in the spreading of the Gospel within its association limits and throughout the world, and 7) Promote christian fellowship.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

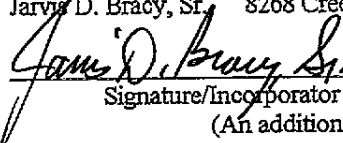
