ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

"The Society" was organized and exists for the sole purpose of aiding its members in planning simple and dignified funeral arrangements at reasonable costs, and to this end has an exclusive contract with a local mortuary.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is: The By-Laws provide for not less than eight trustees to be elected for three year terms; with three trustees elected each year. Officers of the Society are elected for three years by the trustees at their first meeting.
