ARTICLES OF INCORPORATION
OF
FLAMING FIRE DELIVERANCE MINISTRY INC.
(A CORPORATION NOT FOR PROFIT)

We, the undersigned, do hereby join together in the formation of a corporation not for profit for the following specified purposes and under the following terms and conditions, to-wit:

ARTICLE I

The name of this organization shall be FLAMING FIRE DELIVERANCE MINISTRY INC. 1252 McMillian St. Jacksonville, Florida. 32205

ARTICLE II

The general purpose of this corporation is to promote the teachings of the Gospel of JESUS CHRIST & Evangelism of the world and to perform Marriages, Funerals, Baptisms, and like ceremonies.

ARTICLE III

The corporation shall not have any Capital Stock. None membership.

ARTICLE IV

The term of the corporation is perpetual.

ARTICLE V

The activities and affairs of the corporation shall be managed by a Board of Directors.

The number of directors which shall constitute the whole board shall be fixed in manner provided by the by-laws of the corporation, but in no case shall be less than 3.

ARTICLE VI

ARTICLE XI

In accordance with article ten of our Articles of Inc. we hereby make the following amendment C from government form 503-4-35I (9-84) to comply with section 501-C-3 of the federal code:

A. Notwithstanding any other provisions of these articles, the purposes for which the Corp. is organized are excluded, religious, charitable and educational within the meanings of section 501-C-3 of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law.

B. Notwithstanding any other provision of these articles this organization shall not carry on any other activities not permitted to be carried on by organization exempt from Federal Income Tax under section 501-C-3 of the Internal Revenue Code of 1954 or the corresponding provision of any future United States Internal Revenue Law

C. In the event of dissolution, the residual assets of the organizations will be turned over to one or more organizations which themselves are exempt as organizations described in section 501-C-3 and 170-C-2 of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose..

ARTICLE X

The corporation reserves the right to amend, alter, change or repeal any provision contained in the certificate of incorporation in the manner now or hereafter prescribed by the Statute and all rights conferred upon members herein are granted subject to this reservation.
