



WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following Articles of Incorporation for such corporation:

- ARTICLE ONE: The name of the corporation will be PRIESTLY GARMENTS INTERNATIONAL CHURCH, INC.
- ARTICLE TWO: The term for which this corporation shall exist shall be perpetual unless otherwise directed by the Directors and affirmed by the corporation and church members. The term shall begin on the date this corporation is approved by the Secretary of State, Tallahassee, Florida.
- ARTICLE THREE: The purposes for which the corporation is organized are to bring glory to Almighty God through the promulgation of the gospel of Jesus Christ in worship and prayer services; to evangelize the lost; to minister help to the needy and the underprivileged; to train and edify adherents and participants in Bible studies at meetings, seminars, conferences and conventions; to engage in any other lawful act or activity for which not-for-profit corporations may be organized under The Corporation Laws of Florida.
- ARTICLE FOUR: The corporation shall not have any capital stock and the classifications and requirements for membership shall be as set forth in the By-Laws.
- ARTICLE FIVE: The activities and affairs of the corporation shall be managed by a board of directors. The number of directors which shall constitute the whole board

shall be such as from time to time shall be fixed by, or in the manner provided in, the By-Laws, but in no case shall the number be less than 3. The By-Laws shall be adopted by a majority of directors.
