**ARTICLES OF INCORPORATION  
OF**

**JESUS HOLINESS PENTECOSTAL CHURCH, INC.**

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

**ARTICLE I**

The name of this corporation shall be JESUS HOLINESS PENTECOSTAL CHURCH, INC.

**ARTICLE II**

The principal address is 1111 Pamela Street, Leesburg, Florida, 34748.

**ARTICLE III**

The period of the duration of this corporation is perpetual unless dissolved according to law.

**ARTICLE IV**

The purposes of which the corporation is organized are: (1) The organization of a church for religious purposes; (2) to provide a place where Christians can assemble to hear the word of God and to practice and learn about the doctrines and teachings of Jesus Christ; (3) to promote and practice that which the Pentecostal church believe; and (4) to operate exclusively for religious, charitable or educational purposes as a Pentecostal church within the meaning of section 501 (c) (3) of the Internal Revenue Code.

**ARTICLE V**

The method of election of directors shall be stated in the bylaws.

**ARTICLE VI**

This corporation is organized under a non-stock basis.

**ARTICLE VII**

The date of the corporate existence shall begin on the date of filing of these articles pursuant to Florida Statute.

**ARTICLE VIII**

Bylaws of this corporation may be adopted, amended or repealed by the Board of Directors, except as otherwise provided in the Bylaws.

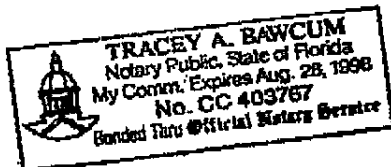
