CHARTER  
OF  
IGLESIA PENTECOSTAL ESPIRITU SANTO, Inc.

The undersigned incorporate, for the purpose of forming a corporation under the Florida not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation shall be: IGLESIA PENTECOSTAL ESPIRITU SANTO, INC. and it is located at 285 Marion Oaks Lane, Ocala, Florida 34473.

ARTICLE II

PRINCIPLE OF OFFICE

The principal place of business is 285 Marion Oaks Lane, Ocala, Florida 34473. The mailing address is 15249 SW 39 CIR, Ocala, Florida 34473.

ARTICLE III

PURPOSE
