**ARTICLES OF INCORPORATION  
OF  
HUMAN RIGHTS COALITION OF HERNANDO COUNTY, INC.**

The undersigned incorporator desiring to form a corporation (hereinafter referred to as the "Corporation") pursuant to the provisions of the State of Florida Not-For-Profit Corporation Laws, execute the following Articles of Incorporation.

**ARTICLE I - NAME**

The name of the corporation is Human Rights Coalition of Hernando County, Inc.

**ARTICLE II - PURPOSES**

The purposes for which the Corporation is formed are:

- (a) To be a voice, advocate, activist, and protector of any citizen of Hernando County who is in jeopardy of having his or her human rights taken away because of prejudice and discrimination;
- (b) To do and perform such acts as may be necessary, advisable, proper or incidental in the realization of the objects and purposes of this organization;
- (c) To exercise all of the powers and privileges and to perform all of the duties and obligations of the Corporation as set forth in the Bylaws; and
- (d) To have and exercise any and all powers, rights and privileges which a corporation organized under the Non-Profit Corporation Law of the State of Florida by law may now or hereafter have or exercise.

**ARTICLE III - TERM OF EXISTENCE**

The period during which the Corporation shall continue is perpetual.

**ARTICLE IV - ADDRESS**

The street address of the principal office of the corporation shall be: 3418 Knotty Oaks Circle, Spring Hill, Florida 34606. The corporation reserves the privilege of having branch or other offices at places within or without the State of Florida.

#### **ARTICLE V - INITIAL REGISTERED AGENT**

The name of the initial registered agent of the corporation is Jeffrey P. Cario<sup>6</sup>/Tew, Zinober, Barnes, Zimmet & Unice. The street address of the initial registered office of the registered agent for service of process shall be 7361 Forest Oaks Boulevard, Spring Hill, Florida 34606.

#### **ARTICLE VI - DIRECTORS**

This corporation shall have eleven (11) directors initially. The affairs of the corporation will be managed by the Directors so designated as provided by the Bylaws of this corporation. The number of directors may be increased from time to time in accordance with the bylaws, provided that the number of directors shall not be less than three persons at any time, in accordance with the statutes.

#### **ARTICLE VII - SUBSCRIBERS**

#### **ARTICLE VIII - BYLAWS**

The initial bylaws of the corporation shall be adopted by the board of directors at the organizational meeting. Thereafter, the power to adopt, alter, amend, or repeal the bylaws shall be vested in the board of directors.

#### **ARTICLE IX - POWERS**

The corporation shall have all of the corporate powers enumerated in Chapter 617, Florida Statutes, as amended from time to time.

#### **ARTICLE X - AMENDMENT OF ARTICLES**

The corporation reserves the right to amend, alter, change, or repeal any provision or provisions contained in these Articles of Incorporation, or any amendment

thereto, in accordance with the laws of the State of Florida, as amended from time to time.

#### ARTICLE XI - DATE OF INCORPORATION

The date of incorporation for the corporation listed above shall be the date of filing of these Articles of Incorporation.

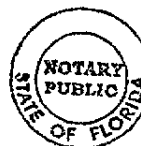


