The name of this corporation shall be Vision of Harvest Ministries, Inc.

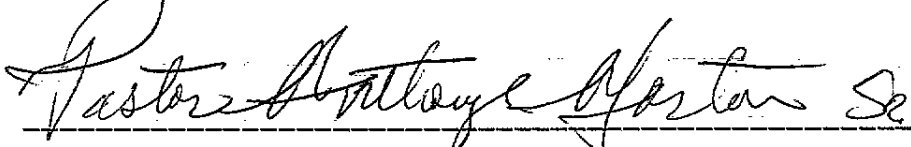
