**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION**

Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

**FIRST:** The name of the corporation is DIAMOND PLAYERS CLUB CHARITIES, INC.

**SECOND:** The following amendment(s) to the articles of incorporation was (were) adopted by the corporation:

**ARTICLE IV - PURPOSE**

The corporation is organized exclusively for scientific, educational and other charitable purposes pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. The corporation is prohibited from engaging in those activities which are not in furtherance of its exempt purposes as stated in this Article, except when these non-exempt activities are an insubstantial part of the organizations activities.

**ARTICLE VII - REGISTERED OFFICE AND AGENT**

The registered agent's office of the Corporation shall be located at 2240 Belleair Road, Suite 160, Clearwater, Florida 33764, and the name of its registered agent at said address shall be Patrick M. O'Connor, Esquire, who states as follows: "I hereby am familiar with and accept the duties and responsibilities as registered agent for said corporation."

**ARTICLE XI - PROHIBITIONS**

The corporation shall not engage or devote more than an insubstantial part of its activities which do not further one or more of the corporation's exempt purposes, including but not limited to the influencing of legislation by propaganda or otherwise directly or indirectly participating in or intervening in any political campaign on behalf or in opposition to any candidate for public office, engaging in those activities not permitted by Section 501(c)(3) of the Internal Revenue Code of 1986 as amended and the regulations hereunder, or to have objectives and to engage in activities that will characterize it as an "action" organization.

## ARTICLE X - DISSOLUTION

Upon the dissolution or liquidation of the corporation, the assets of the corporation shall be distributed to an educational, religious, literary, charitable, or other organization which is similar to the corporation and which organization is exempt under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the assets shall be distributed to the United States of America.

## ARTICLE XII - MANNER OF ELECTION OF DIRECTORS

The Directors shall be elected on an annual basis by the members of the corporation. The duties, removal of and restrictions concerning the Directors shall be governed by the Bylaws. However, the corporation shall, at a minimum, have three (3) Directors




