ARTICLES OF INCORPORATION

FOR

PREAMBLE

I, the undersigned, being of legal age and a natural person, do hereby subscribe to acknowledge and file the following Articles of Incorporation to form a not-for-profit corporation for educational purposes under chapter 617, Florida Statutes.

ARTICLE I

NAME

The name of this corporation shall be:

ST. GEORGE SERBIAN EASTERN ORTHODOX MISSION, CORPORATION (the "Corporation"); and the principal place of business and mailing address shall be 620 94th Avenue North, Naples, Collier County, Florida 34108.

ARTICLE II

OBJECT AND PURPOSE

The purposes for which this Corporation are formed are:

(a) To form a Serbian Orthodox church for religious purposes: worshipping under the Serbian Orthodox faith, educating its members and the public as to the tenets of the Serbian Orthodox faith, and a charitable mission outreach program in the community, as well as any other religious purpose.

(b) In the event of dissolution of this Corporation, all the remaining assets of the Corporation shall be distributed to a Serbian church chosen by the Trustees of the corporation and used only for religious purposes.

ARTICLE III

MEMBERSHIP

The corporation shall have one class of members only, which class shall consist of at least four (4) members. A person who shall apply for membership and pay the minimum annual dues of Two Hundred Dollars (\$200.00) shall become a member of the corporation. Membership in the corporation is not transferable or assignable.

ARTICLE IV

TERM OF EXISTENCE

The term for which this Corporation shall exist shall be perpetual.

ARTICLE V

ARTICLE VI

TRUSTEES

(a) The property, business and affairs of this Corporation shall be managed by a Board of Trustees which shall consist of four members. Said Board of Trustees shall have the rights and duties of trustees of corporations under Chapter 607, Florida Statutes. In no event shall the number of Trustees be less than three. If the number of Trustees determined as provided above shall ever be less than three, the remaining Trustees shall appoint temporary Trustees to act in such capacity until the number of members shall at least equal three. The manner of election for Trustees shall be as provided in the Bylaws.


The Bylaws of this Corporation may be adopted, amended, modified or rescinded by the Trustees of this Corporation.

REGISTERED OFFICE


