**ARTICLES OF INCORPORATION
OF
FORT LAUDERDALE TRACT CLUB INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

Article 1.

The name of the corporation shall be: Fort Lauderdale Tract Club Inc.

Article 11.

The principal place of business and mailing address of this corporation shall be:
1926 NW 9 Street Fort Lauderdale Florida 33311.

Article 111.

The specific purposes for which the corporation is organized are:

- 1 To form a sport club for the children in the local community to train and educate them in various sports activities and promote social skill for it's members.
- 2 To provide leadership roles for the children to emulate and practice for the benefit themselves and their communities.
- 3 To train and expose the children in various athletic activities to bring out their true potential by competition at various local and national championship metes.
- 4 To raise funds to through various promotions by the children and donations from individuals, corporations, clubs or through any legal entities that wishes to contribute.
- 5 To provide the necessary equipment and assessories for the children through fund raising, and gifts to the organization.
- 6 To own and operate the necessary equipment and vehicles to transport the members and other people of the community that must participate in the operation of the club at various locations.
- 7 To be of assistance and to interact with other clubs and associations that are of benefit to the various communities.
- 8 To seek athletic scholarships, and jobs in associated fields or any field that the club may be able to provide assistance to it members.

Article 1V.

The manner in which the directors are elected or appointed are:

- 1 Directors must be volunteers and will be elected by majority vote providing that there are more volunteers than need to fill the positions. If there are not enough volunteers then the President may appoint any volunteer to fill any position.
- 2 All volunteers that become directors must be able to function in their different capacities and must find the time to do and promote club business. If one or more of the directors cannot function, the President may appoint someone else in the director's place until a meeting is held to permanently replace that person.
- 3 There is no term limit for any director.

Article V.

The registered agent for this corporation is Johnny Alexander, who will receive service at 1926 NW 9 Street Fort Lauderdale Florida 33311.

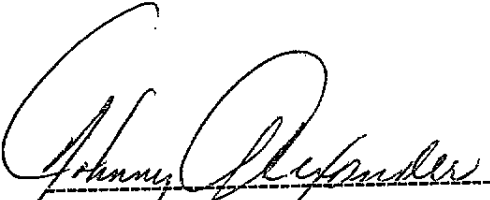

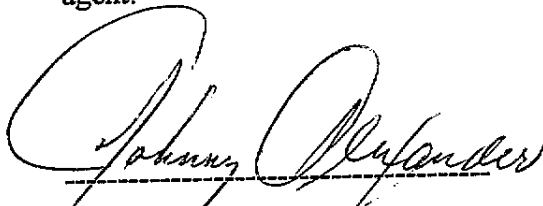

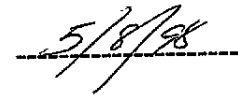
