AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

HORTON PLACE OWNERS ASSOCIATION INC.

A FLORIDA NOT-FOR-PROFIT CORPORATION

Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation. This Corporation's Articles of Incorporation were filed on June 5, 1998; Document Number N98000003247.

ARTICLE I - NAME

The name of this Corporation is:

Horton Place Owners Association Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office of this Corporation is:

310 College Drive Orange Park, FL 32065

ARTICLE III - DURATION

This Corporation commenced its corporate existence on June 5, 1998. This Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

- A. This Corporation is formed pursuant to Section 501(c)(4) of the Internal Revenue Code of 1986, as amended, and shall operate in such a manner as will qualify it as a tax exempt organization thereunder.
- B. This Corporation is organized solely and exclusively for the purpose of providing an entity for the ownership, operation and maintenance of the "Common Area" of a professional and commercial office development more commonly known as HORTON PLACE located in Clay County, Florida.

ARTICLE V - REGISTERED AGENT AND OFFICE

The powers of this Corporation shall be exercised, its properties controlled, and its affairs conducted by a Board of Directors, consisting of not less than three (3) persons. The number of Directors of the Corporation and their manner of election shall be as designated in the Bylaws of the Corporation.

ARTICLE VIII - EARNINGS AND ACTIVITIES OF CORPORATION

- A. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof.
- B. No part of the activities of the Corporation shall include the publishing or distribution of statements or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

- C. Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(4) of the Internal Revenue Code of 1986, as amended.
- D. Notwithstanding any other provision of these Articles, this Corporation shall not, except to a de minimis degree, engage in any activities or exercise any powers that are not in furtherance of the purpose of this Corporation.

ARTICLE IX - AMENDMENT

These Articles of Incorporation may be repealed, altered or amended, and new provisions adopted, by a simple majority vote (greater than 50%) of the Directors present at any regular meeting of the Directors or at any special meeting of the Directors called for that purpose at which a quorum is present. These Articles of Incorporation may be amended by the Directors without a meeting as provided for in the Bylaws.

IN WITNESS WHEREOF, these Amended and Restated Articles of Incorporation were approved by a unanimous vote of the Directors of the Corporation and a unanimous vote of the Members of the Corporation, which was a sufficient number to approve these Amended and Restated Articles of Incorporation, on this 23kp day of November, 1998.
