## **ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

### **ARTICLE I**

#### **Name**

The name of the corporation shall be: Mission Street Ministries, Inc.

### **ARTICLE II**

#### **Principal place of business and mailing address**

The principal place of business and mailing address of this corporation shall be:  
29 East Fifth Street, Panama City, Florida 32401.

### **ARTICLE III**

#### **Purposes**

The specific purpose for which the corporation is organized is:  
to support missionaries throughout the world to spread the gospel of Jesus Christ.

This corporation is formed for charitable purposes under the auspices of Section 501(C)(3) of the United States Internal Revenue Code.

### **ARTICLE IV**

#### **Manner of election of directors**

The manner in which the directors are elected or appointed is as follows:  
Initial directors will be the Incorporators as listed in the Articles. Replacement directors will be elected by majority vote of the directors at the time a vacancy becomes available.

Powers will be those provided in the Internal Revenue Code for corporations formed under the auspices of Section 501(C)(3).

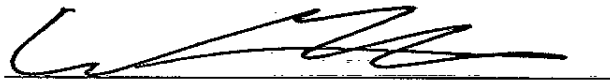

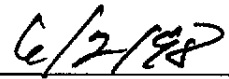
