ARTICLES OF INCORPORATION

FRIENDS OF GOOD SHEPHERD MOBAY, INC.
(A Corporation Not for Profit)

S. C. M. I.

The undersigned hereby submit the following Articles of Incorporation for the formation of a corporation not-for-profit in accordance with the laws in the State of Florida.

I NAME

The name of the corporation shall be FRIENDS OF GOOD SHEPHERD MOBAY, INC. (the "Corporation").

II ADDRESS

The address of the principal office of the Corporation and the mailing address of the Corporation shall be 15351 S.W. 50th Street, Miramar, FL 33027 but the Corporation may maintain offices and transact business in other places within or without the State of Florida as may from time to time be designated by the Board of Directors. Furthermore, the Board of Directors may from time to time relocate the principal office of the Corporation.

III PURPOS<u>E</u>

This Corporation is organized and shall be operated exclusively for charitable purposes, including for such purposes the making of distributions to qualified organization. An organization is a "qualified organization" for purposes of these Articles only if it is described in Section 501(c) (3) and Sections 509 (a) (1) or 509 (a) (2) of the Internal Revenue Code of 1986, or corresponding sections of any future federal tax code. If a qualified organization ceases to be a qualified organization, this Corporation shall not make any further distributions to such organization.

IV <u>DIRECTORS</u>

The governing body of this Corporation shall be the Board of Directors. The Board of Directors of FRIENDS OF GOOD SHEPHERD MOBAY, INC. shall be elected or appointed in accordance of the Bylaws of the Corporation.

V REGISTERED AGENT

The registered office of FRIENDS OF GOOD SHEPHERD MOBAY, INC. shall be located at 550 S.W. 12th Ave., Deerfield Beach, FL 33442. The name and address of the initial registered agent of FRIENDS OF GOOD SHEPHER'S David T. Price, Esq., 550 S.W. 12th Avenue, Deerfield Beach, FL 33442.

VIII OFF<u>ICERS</u>

The affairs of this Corporation shall be managed on a day-to-day basis by the officers in accordance with the Bylaws. The officers shall be appointed from time to time by the Board of Directors. Officers shall serve at the pleasure of the Board of Directors.

X DISSOLUTION

X DURATION

The Corporation shall have perpetual existence.

XI BYLAWS

The first Bylaws shall be adopted by the directors and may be altered, amended or rescinded by the directors in the manner provided by the Bylaws.

XII <u>AMENDMENTS</u>

These Articles may be amended or repealed, in whole or in part, by a majority vote at any duly organized meeting of the directors.

XIII CHARITABLE RESTRICTIONS AND LIMITATIONS

- 1. No part of the net earnings of <u>FRIENDS OF GOOD SHEPHERD MOBAY, INC</u>shall enure to the benefit of or be distributed to its governing Board of Directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payment and distribution in furtherance of the purposes set forth in Article III hereof.
- 2. The Corporation shall not attempt to influence legislation as a substantial part of its activities, nor shall it participate to any extent in any political campaign for or against any candidate for public office.
- 3. It is intended that this Corporation shall have the status of a Corporation which is exempt from Federal income taxation under Section 501 (a) of the Internal Revenue Code, as an organization described in Section 501 (c) (3) of the Code, and described in Section 509 (a) (3) of the Code. These Articles shall be construed accordingly, and all powers and activities of the corporation shall be limited accordingly.
- 4. At no time shall the Board of Directors of the Corporation be constituted so as to be controlled directly or indirectly by one or more disqualified persons with respect to the Corporation (as defined in Section 4946 of the Code) other than "foundation managers" as defined by the Code.
- 5. The Corporation shall at all times be controlled or operated in connection with one or more organizations described in Section 509 (a) (1) or Section 509 (a) (2) of the Code.

XIV UNRELATED BUSINESS ACTIVITY

Notwithstanding any other provision of these Articles of Incorporation, FRIENDS OF GOOD SHEPHERD MOBAY, INC., shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under the provisions of Sections 501 (c) (3) of the Internal Revenue Code as amended or the corresponding provision of any future United States Internal Revenue Code provision or other activities which are prohibited to a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code as amended or the corresponding provision of any future United States Internal Revenue Code provision or other activities which are prohibited to a corporation.
