ARTICLES OF INCORPORATION

of

South Putnam Renaissance, Inc.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act hereby adopts the following Articles of Corporation.

ARTICLE I - CORPORATE NAME

The name of the corporation is:

South Putnam Renaissance, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be 228 South Summit Street, Crescent, FL 32112.

ARTICLE III - PURPOSE

The purpose of the corporation is to improve the community by promoting trade and tourism in the South Putnam County area. The corporation is established under Florida Statute 617 for not-for-profit corporations and is intended to comply with the rules and regulations that would qualify the corporation under Internal Revenue Code Section 501(c)(6) as a business league not organized for profit and no part of the earnings inures to the benefit of any one shareholder.


