## ARTICLES OF INCORPORATION

Executed by the undersigned for the purpose of forming a corporation under the laws of the State of Florida, WITHOUT STOCK AND NOT FOR PROFIT.

Article 1. The name of the corporation shall be: **Sarasota Women's Bowling Association, Inc.**

Article 2. The principal place of business and mailing address of this corporation shall be: 501 Hand Avenue, Sarasota, FL 34232

Article 3. The purposes for which this corporation is organized are:

- A. To include in a central organization all qualified bowlers in the area of Sarasota. The corporation shall be a subsidiary to the Women's International Bowling Congress which is the parent body and the provisions of the mandatory bylaws shall govern the organization subject to the bylaws, rules and regulations of WIBC.
- B. To fulfill the duties of local associations as required by the Women's International Bowling Congress.
- C. To maintain and increase interest in the bowling game for its members and to have and exercise general care and supervision over all activities of its members initiated and/conducted by the local association as permitted by the Women's International Bowling Congress.
- D. To promote, conduct and manage an annual tournament for the members of the Sarasota Bowling Association, the results of which shall determine the championship of the Sarasota Women's Bowling Association, Inc.
- E. To conduct the corporation as a non-profit organization.

Article 4. The manner in which the directors are elected or appointed is: By general membership vote held at annual meeting or determined by the bylaws of the Sarasota Women's Bowling Association, Inc. The number of directors shall be fixed by the bylaws.


