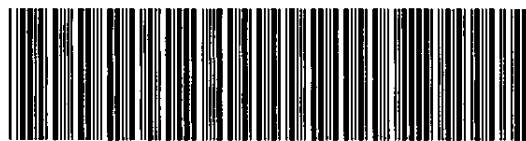



**AMENDMENT TO THE
ARTICLES OF INCORPORATION OF SARIMENTO PROPERTY OWNERS
ASSOCIATION, INC.**

The Declaration of Covenants, Conditions and Restrictions for Sarimento Property Owners Association, Inc. at Addison Reserve is recorded in Official Record Book 10897, at Page 1584, in the Public Records of Palm Beach County, Florida. The Articles of Incorporation of Sarimento Property Owners Association, Inc. is recorded in Official Record Book 10897, at Page 1620, in the Public Records of Palm Beach County, Florida.

As indicated herein, words underlined are added and words ~~struck through~~ are deleted.

Item 1: Article XIV of the Articles of Incorporation of Sarimento Property Owners Association, Inc. ("Articles of Incorporation") shall be amended as follows:

~~Until the Turnover Date (as defined in the Declaration), the Declarant may amend these Articles of Incorporation in its sole and absolute discretion. After the Turnover Date, a~~ Amendments to these Articles of Incorporation shall require the affirmative vote of Members casting ~~sixty-seven percent (67%)~~ a majority of the total votes in the Association in favor of such amendment.
