SECRETARY OF STATE TALLAHASSEE. FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

5-19-98

ARTICLE I

The Corporate name is: THE HOUSE OF JORDAN, INC.

ARTICLE II

DURATION

This Corporation shall commence as of the date of the complete execution and acknowledgment of these Articles and shall have perpetual existence.

ARTICLE III

PURPOSE

The purpose of this Corporation is limited to providing Homes for the Aged or Handicapped in the United States and in the State of Florida.

ARTICLE IV

CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302 Florida Statutes.
