ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are):

Provide plant material skills, design and construction, at no profit, to non-profit organizations and city governments for the purpose of creating visual enhancements for the benefit of our fellow citizens.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

Elections shall be by ballot except when there is only one candidate for an office. The single candidate must receive a unanimous vote of approval. In the absence of a unanimous vote, the President shall solicit challengers. A majority of active members present and voting shall elect. Voting by proxy or absentee ballot is not permitted.
