001

THE UNDERSIGNED INCORPORATOR, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA NOT FOR PROFIT CORPORATION/ACT, HEREBY ADOPT(S) THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I NAME

THE NAME OF THE CORPORATION SHALL BE:

ARTICLE III PURPOSE(S)

THE SPECIFIC PURPOSE(S) FOR WHICH THE CORPORATION IS ORGANIZED IS(ARE):

- TO COOPERATE WITH OTHER CHAMBERS OF COMMERCE, SOCIAL, CULTURAL, ACADEMIC, AND GOVERNMENTAL ORGANIZATIONS TO PROMOTE TRADE, EXCHANGE OF INFORMATION, VISITS AND CONFERENCES BETWEEN THE UNITED STATES, FLORIDA, THE AMERICAS, AND BRASIL,
- MAINTAIN COMPLETE, CORRECT AND UP-TO-DATE RECORDS OF ALL FBCC MEMBERS, HOME AND ABROAD,
- PUBLISH AN INTERNET HOME PAGE WITH INFORMATION ABOUT ALL MEMBER ORGANIZATIONS, THEREBY MAKING IT EASY AND CONVENIENT FOR EVERYONE ANYWHERE IN THE WORLD TO FIND AND CONTACT THE FBCC AND THEIR MEMBERS. INTERNET WEB SITES OF MEMBER CHAMBERS ARE HYPER LINKED TO FBCC,
- ORGANIZE MAJOR EVENTS, A LUNCHEON OR RECEPTION/DINNER JOINTLY HOSTED BY ALL THE FBCC MEMBER ORGANIZATIONS, AND FEATURING INTERNATIONALLY RENOWNED SPEAKERS.
