**ARTICLES OF INCORPORATION.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I NAME.** The name of the corporation shall be : "PEACE RIVER CHAPTER 1226 EXPERIMENTAL AIRCRAFT ASSOCIATION, INC."

**ARTICLE II PRINIPAL OFFICE.** The principal place of business and mailing address of this corporation shall be. ARCADIA MUNICIPAL AIRPORT , ARCADIA FL. 34266. Mailing address shall be. THOMAS R. O'HANLON P.O. BOX 296 FT. OGDEN, FL. 34267.

**ARTICLE III PURPOSE (S)** The specific purpose(s) for which the corporation is organized is (are).

- a. To promote and encourage the sport and hobby of recreational aviation.
- b. To corporate with and assist governmental agencies in the development of programs relating to aviation activities.
- c. To encourage and engage in research for the improvement and better understanding of aviation and the science of aeronautics.
- d. To foster, promote and engage in aviation education.
- e. To promote and encourage grass roots efforts relating to aviation research and development.
- g. To foster closer fellowship among its member through the exchange of ideas of mutual interest.
- h. To operate as a local Chapter of the Aircraft Association, Inc. (The "EAA"), to cooperate with the EAA and to further the goals and purposes of the Association within the geographic area served by the corporation and comply in all policies and procedures of the EAA as that Association might establish for its Chapters at any time and from time to time .

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS..** The manner in which the directors are elected or appointed is: Anominating committee consisting of five Chapter members shall be selected by the Board of Directors no less than 90 days prior to the annual membership meeting. The Committee shall select at least one candidate for each Principal Office and position on the Board of Directors to be filled at such meeting and shall present the slate of candidates to the members not less than thirty days prior to the meeting, either by mail or by including such slate in a publication mailed to members.

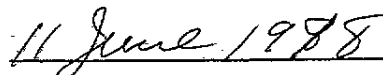
