ARTICLES OF AMENDMENT

to

ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendments adopted:

A. Article Number I was amended to read:

The name of the corporation, hereinafter called the "Corporation", shall be Grandview Gymnatorium of Boca Raton, Inc., and the street address of its principal office is 21218-10 St. Andrews Blvd., #602, Boca Raton, FL 33433

B. Article Number II was amended to read:

The purposes for which the Corporation is to be organized are exclusively for educational, charitable, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to the extent consistent with these purposes and to that end: to take and hold by bequest, devise, gift, grant, purchase, lease or otherwise, any property, real, personal, tangible or intangible, or any undivided interest therein, without limitation as to amount or value; to sell, convey, or otherwise dispose of any such property and to invest, reinvest, or deal with the principal or the income thereof in such manner as, in the judgment of the Directors, will best promote the purposes of the Corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, this Certificate of Incorporation, the bylaws of the Corporation, or any laws applicable thereto; to enhance the cultural, recreational, educational and information environment of the community by constructing a gymnasium; to provide access to such gymnasium facilities throughout greater Boca Raton, Florida, neighborhoods for all people; and to provide enrichment to the community through special programs at such fa-

cilities. This Corporation has a racially nondiscriminatory policy and it does not discriminate on the basis of race, color, or national or ethnic origin.
