**ARTICLES OF INCORPORATION**

*The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:*

**ARTICLE I**  
**Name**

The name of the corporation shall be SPIRIT LIFE FELLOWSHIP, INC.

**ARTICLE II**  
**Principal Place of Business and Mailing Address**

The principal place of business of this corporation shall be 2120 Airport Road, Lakeland, Florida, and the mailing address of this corporation shall be P.O. Box 774, Lakeland, Florida 33802.

**ARTICLE III**  
**Commencement of Corporation**

This corporation shall commence its corporate existence on June 19, 1998.

**ARTICLE IV**  
**Duration**

This corporation shall have continual indefinite existence.

**ARTICLE V**  
**Purpose**
