We, the undersigned, do hereby join and associate ourselves together for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Bayshore High School Athletic Boosters, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 703 65th Avenue Drive West, Bradenton, Florida 34207.

ARTICLE III PURPOSES

The specific purposes for which the corporation is organized are:

1. To encourage, foster, honor, improve and expand athletics and sports, the participants therein, and the values associated therewith, at Bayshore High School in Manatee County, Florida, through the donation of resources and the giving of time and talent.
2. To do all acts and things necessary, convenient or expedient to carry on the above-mentioned purposes.
