TO THE ARTICLES OF INCORPORATION  
OF

Pursuant to Fla. Stat. §617.1002 ("Procedure for Amending Articles of Incorporation"), Fla. Stat. §617.1006 ("Contents of Articles of Amendment") and Fla. Stat. §617.0401 ("Corporate Name"), the articles of incorporation of the above not-for-profit corporation are amended as follows:

1. The name of the corporation is: The Sammy Sosa Charitable Foundation, Inc.
2. The following amendments to the Articles of Incorporation were adopted changing Articles I and II to read as follows:

- A. Article I is hereby amended to read as follows:

**"ARTICLE I**

- B. Article II is hereby amended to read as follows:

**"ARTICLE II**
