The undersigned hereby organize a corporation under the provisions of the Florida Not for Profit Corporation Act, and pursuant to the following Articles of Incorporation.

**ARTICLE I**

**Name**

**Election of Directors**


The method of election of directors shall be stated in the bylaws.


