ONE: The name and address of this principal corporation is Rainbow Shelter for Women & Family, Inc., 1931 N.W. 194<sup>th</sup> Terrace, Coral City, Florida 33056, in Dade County. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

The programs will consist of but shall not be limited to: Job Training, Job Placement, Land Acquisition, housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring,. AIDS, Elderly Care and other programs to aid those in need.

**THREE**: The duration of this corporation shall be perpetual, no stock and shall have no members.
