# ARTICLES OF INCORPORATION OF CENTER ICE, INC.

The undersigned incorporators, for the purposes of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I - NAME**

The name of the Corporation shall be CENTER ICE, INC.

#### **ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of the Corporation shall be 8000 Governor's Square Boulevard, Suite 410, Miami Lakes, Florida 33016.

#### **ARTICLE III - PURPOSES**

The specific purpose for which the Corporation is organized is to organize and operate a youth hockey program to provide youths of the South Florida area with the opportunity to participate in organized team competition under proper guidance and to teach such youths the principles of good sportsmanship, the fundamentals of ice skating, and the elements of ice hockey. The Corporation will also establish a travel program specific to South Florida ice arenas which may include Pembroke Pines, Sunrise, Coral Springs, West Palm Beach, Pompano, Kendall, and Miami.

#### ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

The Board of Directors shall advise the general membership of its purpose via separate mailing and shall formulate from the mailing, during the December Board Meeting, a slate of committed candidates. At that time, all candidates are requested to attend the March Board Meeting so that all candidates can be introduced and be provided the opportunity to answer any questions from the general membership in attendance. Each candidate may submit a letter of purpose with the February nominee mailing.

ECRETARY OF STAT

At the conclusion of the January Board Meeting, a ballot shall be prepared by the Board of Directors listing the candidates for their prospective offices and distributed via separate mailing (one per family) among the general membership and current Coaches and Board Members. A simple majority is needed to elect the prospective officers. Ballots must be received prior to the February Board Meeting. All ballots will remain sealed until the April Board Meeting. At that time, the ballots will be opened and counted.

The new Board of Directors shall be introduced at the last Board Meeting of the fiscal year. The new Board of Directors shall be responsible for the operation of the corporation effective with the April monthly Board Meeting.
