ARTICLES OF INCORPORATION
JESUS IS THE ANSWER FOR THE WORLD REVIVALS, INC.

We, the undersigned, do hereby associate ourselves together for the purpose of becoming incorporated under the Laws of The State of Florida applicable to corporations not for profit, and do hereby certify that:

ARTICLE 1

NAME: The name of the corporation shall be Jesus Is The Answer For The World Revivals, Inc., with the principal office located at 1658 Glendale Ave. N.W., Palm Bay FL 32907.

ARTICLE II

AFFILIATION: Jesus Is The Answer For The World Revivals, Inc., has been duly set in order and is officially affiliated with the Association of International Gospel Assemblies, Inc., and is in fact an Evangelistic Organization, possessing all the rights, privileges, and authority of a church body. This subordinate organization is recognized as Federal Tax Exempt under Group Exemption Number 9445. Abiding by the ordinances of this locality, no person or persons have the right to hinder, or interfere with this evangelistic body in the exercise of these rights. The office of the Association of International Gospel Assemblies, Inc. is located at 411 South Third St., DeSoto, Missouri 63020. The By-Laws of this corporation shall in no way conflict with the Constitution and By-Laws of the Association of International Gospel Assemblies as now or hereafter are duly adopted.

ARTICLE III

PURPOSE: The general objects and purposes for which this corporation is organized is to preach and teach the Gospel of Jesus Christ as set forth in the Old and New Testament Scriptures; to practice and promote the Christian Religion according to the Gospel of the New Testament Scriptures; to convert persons to the Christian Religion;

to build for religious worship and instruction, churches, schools of Bible training or theology, pastori-ums, or other charitable and benevolent institutions connected therewith of a religious and educational character, to the end that mankind may be generally instructed and guided concerning those Articles of Faith which are most surely held among the Association of International Gospel Assemblies, Inc.; to receive grants, offerings, gifts and any other charitable donations for the furtherance of the aforesaid objects and purposes.

Said corporation is organized exclusively for religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501 (c) (3) of the Internal Revenue Code.

In general, doing anything necessary, proper, advisable and convenient for the accomplishment of the above said purposes, and to do all other things incidental to them or connected with them that are not forbidden by the Florida Corporation laws or by these Articles of Incorporation.

No part of the net earnings of this corporation shall inure to and for the benefit of or be distributed to its adherents, officers, or other private persons, except that the corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions for charitable or religious purposes.

ARTICLE IV

BOARD OF DIRECTORS: The initial Board of Directors shall consist of four (4) members who shall be residents of the State of Florida. The Board of Directors from its number shall elect the officers of the corporation which shall be the governing body.

ARTICLE V

OFFICERS: Said officers shall consist of an Evangelist/Director, Secretary, Treasurer, and Trustees comprising the corporate board of the corporation. The By-laws said corporation and subordinate ministry shall in no way conflict with the Constitution and By-laws of the Association of International Gospel Assemblies as now or hereinafter are duly adopted.

The Evangelist who is director of this affiliated ministry must be a minister who is Licensed or Ordained by the Association of International Gospel Assemblies, Inc., and said Evangelist or his/her successor must remain in good standing with this Association in order for said Evangelistic Charter to be valid.

ARTICLE VI

TERM: this corporation shall have perpetual existence.

ARTICLE VII

INITIAL REGISTERED OFFICE AND NAME OF INITIAL REGISTERED

AGENT: The location of this corporation shall be 1658 Glendale Ave. N.W., Palm Bay, FL 32907, Brevard County, FL. Said location may be subject to change by the Board of Directors. The initial Registered Agent of the corporation will be Rev. Ann Marie Toraya, 1658 Glendale Ave. N.W., Palm Bay, FL 32907

ARTICLE VIII

ARTICLE IX

DISSOLUTION: Upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purpose of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for such organization or organizations , as said Court shall determine which are organized and operated exclusively for such purposes.

ARTICLE X

AMENDMENTS: These Articles of Incorporation may be amended by a majority vote of the Board of Directors. The amendments of said subordinate ministry and corporation may not conflict with the Constitution and By-Laws of the Association of International Gospel Assemblies, Inc.

ARTICLE XI

BY-LAWS: The Board of Directors of the corporation shall have the right to adopt and make such by-laws as it shall deem proper and advisable and such by-laws shall be made, altered, or rescinded upon the majority vote of the directors present and voting

at any regular or special business meeting of the corporation called for that purpose. The by-laws of said subordinate ministry and corporation shall in no way conflict with the Constitution and By-Laws of the Association of International Gospel Assemblies, Inc.
