**ARTICLES OF INCORPORATION
FOR A NON PROFIT CORPORATION**

ARTICLE I - NAME

The name of the corporation shall be: Project Family First, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office shall be: 1481 7th Street, West Palm Beach, Florida 33401.

ARTICLE III - PURPOSE(S)

Project Family First was developed to address the needs of families and increase parental involvement in the education and behavior of their children. Problems of dysfunction such as unemployment, low education achievement, self - esteem and poor parenting skills in the family unit often negatively affect children's school performance. Project Family First provides an opportunity for parents to improve their educational achievement, self-esteem, employability, and parenting skills through adult education classes and educational/vocational counseling; as well as parenting classes.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

An initial Board of Directors will be put in place by the incorporator of these articles. Upon vacancies on that board, nominations will be given and applications accepted, reviewed and voted on by the Board of Directors to fill such vacancies, as stated in the bylaws.


ARTICLE V - INITIAL REGISTERED AGENT and STREET ADDRESS

The name and Florida street address of the initial registered agent are: Thelma Mainer who is located at 1481 7th Street, West Palm Beach, FL 33401.


ARTICLE VI - INCORPORATOR
