The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

### ARTICLE I: NAME

The name of the corporation is **FLORIDA MARITIME SERVICES CORPORATION**

### ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **315 South Calhoun Street, Suite 712, Tallahassee, Florida 32301.**

## **ARTICLE X: AMENDMENTS**


The corporation reserves the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.


