ARTICLE I
NAME

ARTICLE II
THE PERIOD OF DURATION IS PERPETUAL

ARTICLE III
PURPOSES

The organization is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 © (3) of the internal revenue code , or corresponding section of any future federal tax code. The corporation may receive and administer funds for scientific, religious, educational, and charitable purposes, within the meaning of section 501 © (3) of the internal revenue code of 1986 and to that end, the corporation is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purpose of the corporation, without limitation, except such limitations, if any as may be contained in the instrument under which such property is received, these Articles of Incorporation, by the by-laws of the Corporation, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the NON-PROFIT Corporation Law. Our interest are to reach the community which surround our premises and with our aid do everything possible to help the community. With the spiritual as well as with the material needs, following with the teachings of our Lord Jesus Christ therefore, this mission is willing to extend its hands to aid who ever is in need with out discriminating against race, color, religion, or sex. ARTICLE IV
MEMBERS

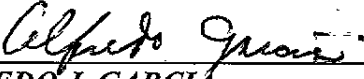
