Articles of Incorporation of Alliance of Appointed Ambassadors, Inc.



ARTICLE I.

NAME

Section 1.1 The name of this organization shall be the Alliance of Appointed Ambassadors, Inc.

ARTICLE III.

PURPOSES

Section 3.1 Purposes

Section 4.4 Executive Committee

ARTICLE V.

LIMITATIONS

Section 5.1 Limitations on Actions

No part of the net earnings of the organization shall inure to the benefit of, or be distributed to any member, director, officer, or other private person, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to confer benefits on its members in conformity with the purposes set forth in Section 3.1 of these Articles. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Law).
