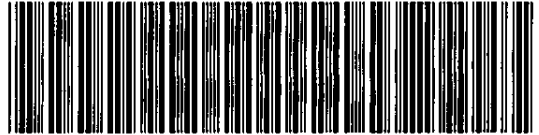

Enclosed please find the following:


