ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

COMMUNITY CARE HEALTH SERVICES, INC., a Corporation Organized for Charitable Purposes

Pursuant to the provisions of Section 617.1001 and 617.1002, Florida Statutes, the undersigned corporation submits the following articles of amendment:

- The name of the corporation is COMMUNITY CARE HEALTH SERVICES, INC.
- 2. The following amendments to the articles of incorporation were adopted by the board of directors in the absence of any members on March 19, 1999:

ARTICLE III

The corporation is a not for profit corporation. The purposes for which the corporation is organized are:

- a. The general purposes for which this corporation is formed are to operate exclusively for charitable and educational purposes which will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provisions of any subsequent federal tax laws, including, for those purposes, the making of distributions to organizations which qualify as tax exempt organizations under that code.
- b. This corporation shall not, as a substantial part of its activities, carry on propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene, by publication or distribution of any statements or otherwise, in any political campaign on behalf of any candidate for public office.

- c. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- The above stated amendments shall become effective on March 19,
 1999.
