ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation.

Article I Name

The name of the corporation shall be:
CommuniCare Family Life Center Inc.

Article II Principal Office

The principle place of business and mailing address of this corporation shall be:

Article III Purpose (s)

The specific purpose(s) for which the corporation is organized is (are):

1. To provide comprehensive accessible community based and community delivered support services that restores and strengthen the family through providing early intervention, prevention and rehabilitative services that are culturally, ethnically, linguistically responsive to the needs of the family.
2. To empower the family to make informed and self directed decisions about all aspects of their lives.
3. To increase the ability of the family to cope during crises.
4. To provide advocacy by bringing to the attention of appropriate authorities the unmet needs of families in the community and insure all levels of government planning addresses their needs.
5. To establishes collaborative alliance with institutions and agencies that provide services to meet the needs of families in the community.
6. To do any lawful activities permitted which may be necessary for the accomplishment of this cooperation purposes directly or indirectly either alone or in conjunction with other persons or corporations, firms, associations, institutions, foundations, or governmental agencies, bureaus, or departments. All activities will be within the guidelines of the State of Florida Nonprofit Corporation, Statute Ch. 496, entitled., "solicitation of Funds Act" and Federal and State Income Tax under section 501 (c) (3) of the Internal Revenue.

Article IV Manner of Election of Directors

The manner in which the directors are elected or appointed is:

1. The officer of this cooperation shall be the President, Vice President, Secretary and Treasure they shall serve perpetual terms.
2. The Board of Director will consist of five or more Directors.
3. The Board of Director candidates shall be in good moral and legal standing in the community and has volunteered his/her services for one or more years to this cooperation, except for the first term. The Board of Director will be appointed by the President for the first term. The candidates appointment will be with no discrimination base on race, creed, sex, religion or national origin.
4. The Board of Director positions, shall be filled by the President with the approval of the Officers and Board of Directors. Board members shall be appointed for a term of three (3) years and may not serve more than two consecutive terms.

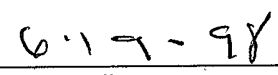
