ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Grace Community Church of DeFuniak Springs, Inc.

ARTICLE II - DURATION

The corporation shall exist perpetually.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office of the corporation shall be 401 N. 5th Street, DeFuniak Springs, Florida 32433, and the mailing address of the corporation shall be Post Office Box 1356, DeFuniak Springs, Florida 32435.

ARTICLE IV - PURPOSE OF THE CORPORATION

The purpose of the corporation is to assemble together as a group of believers in the Lord Jesus Christ, for the express purpose to fulfill and carry out His Divine Commission as commanded in His Holy Word (as stated in the Articles of Incorporation and By-Laws).

ARTICLE V - MEMBERSHIP

The qualifications for members and the manner of their admission shall be regulated by the By-Laws.

ARTICLE VI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE IX - AMENDMENTS


Amendments of these Articles shall be amended at any quarterly, annual, or
